Program: Aquatic Invasive Species

Implementation of the CBSA Single Window Initiative (SWI)

Aquatic Invasive Species (AIS) are a major threat to Canada's environment and economy. Aquatic invasive species establish themselves in our coastal or inland waters and can spread rapidly, radically altering habitat resulting in reductions or outright extinction of indigenous fish and local fisheries. The most effective approach to dealing with species that are (or could become) established in Canada involves managing the pathways through which invasive species enter and spread through Canadian waters.

For aquatic species, these pathways are shipping, recreational and commercial boating, the use of live bait, the aquarium/water garden trade, live food fish, unauthorized introductions and transfers, and canals and water diversions. Fisheries and Oceans Canada (DFO) leads many initiatives that aim to minimize the threats that AIS pose to the Canadian ecosystem.

Non-Eviscerated Asian Carp, Quagga or Zebra mussels are goods prohibited for importation under the Aquatic Invasive Species Regulations.

These species can be imported if the purpose of importation is intended for scientific, educational, Aquatic Invasive species control end-use and if the importer is an employee or any other person acting under the direction of an educational institution, a research facility, a zoo or an aquarium, or if the importer is an employee or any other person acting under the direction of a federal or provincial department with a mandate to manage or control aquatic invasive species. The appropriate permit type (SG9/SG121) must be submitted.

Under the Single Window Initiative, release requests will be submitted utilizing a new Integrated Import Declaration (IID) that allows custom brokers to submit and obtain electronic release for goods also regulated by participating department and agencies.

Release requests for regulated Fisheries and Ocean under the Aquatic Invasive Species program may be provided to the CBSA electronically by submitting an IID and Document Image Functionality (DIF), License, Permit, Certificates and other document (LPCO). The IID must include the following information:

- a. Import License number
- b. License, Permits, Certificate and other (LPCO) information
- c. Permit number

Note: Under SWI, information requirements will remain the same. There are no additional data requirements for the import process.

Regulated goods:

The following are regulated:

- Aquatic invasive species
- Live fish
- Fish fresh, chilled or frozen
- Molluscs (Zebra and Quagga mussels)

Excludes fish fillets and other fish meat.

Documents required:

- · Aquatic Animal Health Import permit
- SFC License
- Foreign Processing Establishment
- · Zoosanitary certificate

The EDI transaction notification from CBSA to the importer / broker of "Approved", only signifies that the documentation provided to the CBSA has been accepted. The product is allowed entry into Canada to the destination identified on the import, and is subject to inspection.

Commercial importations

Importers or the person in possession, or care and control of the goods are responsible for ensuring that their goods comply with the requirements of all government departments and agencies prior to importation into Canada.

The importer must have a valid SFC license. Fish and fish products imported without a valid import licenselicense will be refused entry into Canada.

Aquatic Animals (live or dead)

Under the **Health of Animals Regulations** there are additional information requirements that must be declared upon entry, including the scientific or taxonomic names for finfish, crustaceans, and molluscs. Consequently, travelers and commercial importers must report scientific names of all imported aquatic species in the commodity description field of **Form CI1**, **Canada Customs Invoice** or the commercial invoice, either electronic or paper, as per the instructions in **Memorandum D1-4-1**, **CBSA Invoice Requirements**, and/or in accordance with the technical requirements, specifications and procedures for electronic data interchange as set out in the **Electronic Commerce Client Requirements Document** (ECCRD). In addition to taxonomic names, travelers and commercial importers must declare the number of aquatic animals being imported, the life stage, the country in which the aquatic animal was born or where the germplasm came from, and whether the animals are from captivity or the wild.
